Daily High Percentage Award for Each Show: Highest Percentage in each Division Open, Adult Amateur, and Junior at each show will receive a great prize and a high point ribbon! Ribbons will be awarded for placings first through fifth.

Silver Series High Point Award: To qualify for the series high point, you must compete at a minimum of 2 SilverLake's Shows. We will take the 2 highest scores for each Horse/Rider Combination and the highest average at each level and in each division Open/Adult Amateur/Junior will receive a great prize and ribbon.

Rules and Information: Every class offered herein which is covered by the rules and specifications of the current USEF Rule Book will be conducted and judged in accordance therewith. Please note that any pending rule changes may affect this competition. They will be posted on the USEF website, www.usef.org up to and including the day before the show begins. It is up to the competitors to know, understand, and follow competition rules. Current WDAA, USDF, USEF, FEI and Cowboy Dressage tests will be used.
